The Elstead and Weyburn Neighbourhood Development Plan
Application for the designation of a neighbourhood area
Regulation 6 - Town and Country Planning, England - The Neighbourhood
Planning (General) Regulations 2012

The Localism Act 2011 allows for local people to prepare a neighbourhood development plan so that they can influence the future of their own communities by planning where and what type of new development will take place in their areas and what it should look like. Where an area is covered by a town or parish council, the neighbourhood development plan can only be prepared by that town or parish council.

Elstead Parish Council and Peper Harow Parish have resolved to prepare a neighbourhood development plan. Therefore, under the above Regulations they have applied to Waverley Borough Council to designate the area that the Elstead and Weyburn Neighbourhood Development Plan is to cover (known as the neighbourhood area).
